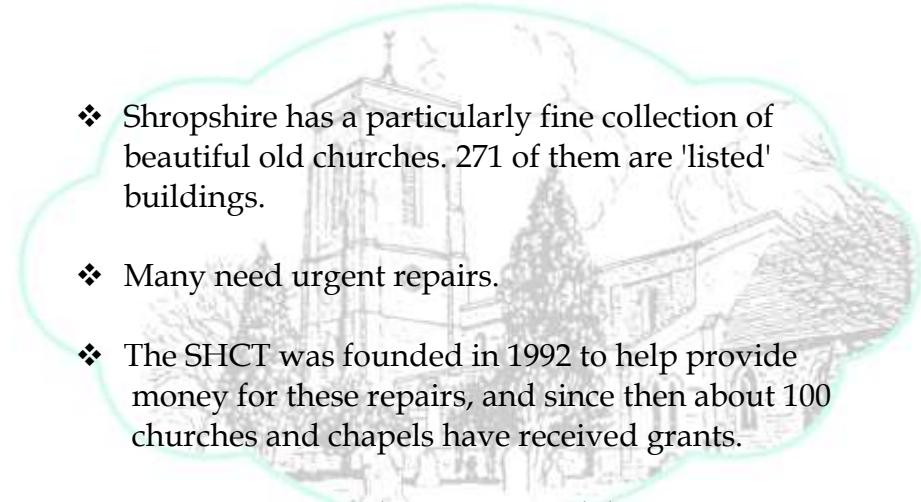


# SHROPSHIRE HISTORIC CHURCHES TRUST
